


MINUTES OF THE MEETING FOR REDRESSAL OF GRIEVANCE COMMITTEE

Kook Pharmaceutical CO Ltd, South Korea & is purchased in a lot of Public/Private institution in Punjab .

In case of Pofol it is not that manufacturing technology is taken from some other company, the fact of the matter is that Dong Kook itself has successfully synthesized propofol and developed a propofal based emulsion of use in injection.

Human clinical studies were also performed and one of the studies based on double blind method was performed at seoul national university hospital anesthesia department.

It was concluded that Paofol (Produced by Dong Kook Pharm co Ltd) when compared with Brand D shoed no difference in efficacy . In terms of safety the frequency of said effects was about the same for both, and these side effects cleared up without any difficulty. A Comparative clinical study of Pofol & Propofal Lipuro was also conduct in LRH Peshwar and pofol was found more effective.

We has also provided the samples in the current tender so that the samples may be used to evaluate the efficacy of product. Whatever the efficacy you found may be given to our firm so that we may discuss it with our principal /Ms/Dong Kook , Seoul Korea.

committee evaluated the matter. End user disapproved the product and did not recommend it in Part C.

After due deliberation, the committee unanimously decided to **uphold** the decision of T.E.C.


Hence the grievance is **rejected**.
