<p>For Code No A014,15,33 PROCUREMENT OF Medicine.</p> <p><b>M/S – FDL Frontier Dextrose Limited</b> submitted a grievance vide their letter No. 06 October 2020 bearing Diary No.1443 Dated 21.10.2020.</p> <p>M/S – FDL Frontier Dextrose Limited submitted grievance against M/s- Unisa Pharma</p> <p>This is worth to mention here that the firm has to provide an undertaking on stamp paper worth Rs.100 (minimum)0 i.e. Non Declaration of spurious /Adulterated batch by DTSs of the Punjab/ any as per Evaluation Criteria for Drug/Medicines Part-A Compulsory .</p> <p>1</p> <p>M/s- Unisa Pharma has also submitted the said undertaking along with its bid but unfortunately 3 batches of M/s- Unisa Pharma have been declared as sub standard by the DTL.</p> <p>You are requested to please look into the matter and take strict notice against the firm M/s- Unisa Pharma for providing forged documents on Judaic Paper against said tender for Drugs/Medicines for the financial year 2020-21.</p>	<p>M/s- Unisa Pharma is responsive against code NO. A014,15,33</p>	<p>Representatives from both firms were asked to attend the meeting. They explained their matter one by one and presented the documents relating testing reports of DTLs and decisions of Provincial Quality Control Board. The committee scrutinized these reports to conclude this matter in a meaningful way. However the committee reprimanded the representatives of the companies for this negligence and to be very cautious in any next such process.</p> <p>After due deliberation and detailed evaluation, the committee unanimously decided to declare the bid of <b>UNISA</b> pharmaceutical Industries Ltd. as <b>non-responsive</b> only for <b>T.E 2</b> ( Dextrose 10% 1000ml) , <b>T.E 7</b> (5% Dextrose Saline 1000ml) in <b>PP- A 033</b>. All other results of T.E.C will be upheld for A-014 and A-015.</p> <p>Moreover the bid of FDL is also declared non responsive for <b>T.E 10</b> (Dextrose 4.3% &amp; NaCl 0.13%) , <b>TE 17</b> and <b>T.E 18</b> for <b>PP A-033</b>.
