The firm added that these Items are very expensive and can show to the end User for evaluation. The firm claimed that its all products are registered with DRAP.

Decision:

Mr. Ali Aslam, Sales Executive pleaded the case of firm before the grievances committee. The firm's representative desired to plead the grievance for T.E. 39, 40, 41, 45 & 46. The committee observed that Technical Evaluaiton Committee has declared T.E. 39, 40, & 41 non-responsive in Part-A & Part-C due to non-provision of samples and T.E. 45 & 46 as non-responsive due to different specifications. The firm's representative stated that it has quoted these items for the first time and did not provide samples being expensive.
