ITEM NO. 01: GRIEVANCE SUBMITTED BY M/S ANAX ASSOCIATES (PVT.) LTD.

(TENDER CODE: A016: CSSD)

GRIEVANCE DETAIL: The firm submitted the grievance that M/s Anax Associates (Pvt) Ltd. is

technically not accepted due to incomplete compulsory documents while all $% \left\{ 1,2,\ldots,n\right\}$

product samples are approved by end user on quality basis. The firm claimed

that in compulsory parameters the affidavit is attached but the technical

evaluator asked to provide the affidavit with the two years warrantee,

whereas in bid it provided 3 years warrantee of not black listing/no batch

failed. The firm requested to accept its grievance, accept the affidavit with

the warrantee of 2 Years attached with this letter.

Mr. Mohsin Zaheer, Institutional Sales Manager pleaded the case of firm before the grievances committee to the extent of Section 5 (iii) of Part-A. The

committee observed that Technical Evaluation Committee (TEC) has

mentioned that the firm has not mentioned 'Two Years' duration on Affidavit.

The firm provided an Affidavit bearing ID PB-LHR-60128DE8B8923C00 issued

on 18th April 2023. The committee accepted the grievance and declared the

bid responsive in section 5 (iii) of Part-A.

GRIEVANCE SUBMITTED BY M/S GLOBAL MARKETING SERVICES (TENDER CODE: A016: CSSD)

GRIEVANCE DETAIL:

The firm submitted the grievance with reference to Technical Evaluation of A-014 (Disinfectants and CSSD Disposable Items F.Y 2023-24. The firm stated that it has not technically qualified in tender for the T.E. Sr. nos. 1,2,3,4,5,6,7,8,10,11,12,13,14,15,17,18,24,27 due to non-labeling on the products and due to non-provision of samples. The detail is given below:

Sr.No. 1,2, (Steri Green Crepe Paper) non responsive due to non labeling on products

The firm claimed that it quoted STERIS COORPORATION products in tender and Brand name is mentioned on each box not on each item.

Sr.No. 3,4,5,6,7,8,10,11,12,13,14, (Packing Reels: FLAT & GUSSETED)

The firm claimed that it is the sole distributor of STERIS COORPORATION in Pakistan and Brand name STERIS is mentioned on all mentioned items on both reels sides.

Sr. No. 15 (Lead Free & latex Free Autoclave) non-responsive due to non-labeling on item

The firm claimed that it has quoted STERIS COORPORATION products in tender and Brand name is mentioned on each box not on each item.

Sr. no. 17 Manual Printing 3 Line labeling Gun with ink cartridges is nonresponsive due to sample not provided

The firm stated that the quoted item is very expensive and is the type of machine. The firm added that it had delivered the product demo to the end user, which they can also deliver to GRC on return basis.

Sr.no. 18. Double Adhesive 3 Line Labels with Process Indicator for Steam is non-responsive due to sample not provided

The firm claimed that it submitted samples with tender for which hospital receiving has been attached

Manual Lubricant for treatment of surgical instruments, CFC & silicon Free.

According to European Pharmacopia Recommendations is non-responsive due to thinner layer on instruments.

The firm claimed that it is offering the one of the leading brand that is used in well renowned hospitals in Pakistan and institutes are satisfied with its product for which the hospital POs have been attached.

Sr.No. Package monitoring indicator for H2O2 sterilizers (Box of 3200) is non-responsive due to the Indicator color not changed

The firm claimed that it has quoted one of the best brands in the tender that are used in different hospitals in Pakistan that are satisfied with its product for which WIC PO is attached.

The firm reiterated that GMS is offering STERIS products which are FDA approved and CE marked.

Mr.Sharjeel, Senior Sales Executive pleaded the case of firm before the grievances committee. The detail of proceedings is given below:
