GRIEVANCE DETAIL:

The firm submitted the grievance that the firm participated in Tender for Linen items for the year 2023-2024. The firm claimed that it was technically responsive in FY 2022-2023 and in 2023-2024 we are also declared technically responsive. The firm stated that the security attached is not as per the criteria. The firm claimed that it had attached the same instrument In FY 2022-2023 and even the performance Guarantee of 5% for the FY 2022-2023 was generated from the same bank where no objection was raised by the technical team. Observing the previous years, the firm followed the same pattern for making 2% bid security, and requested to accept its Grievance and make responsive for Financial Bid results..

Decision:

Mr. Ameen, Business Partner of firm pleaded the case of firm before the grievances committee. The committee observed that the firm has been disqualified due to invalid Bid Security as it was in the shape of Pay Order. The firm added that they have attached Pay Order and stated that the bid security purpose is to secure the bid only. The committee also discussed the advice of PPRA Punjab through Letter No. L&M(PPRA)1-15(SOC)(AB)(LHR)(5)/2020
