GRIEVANCE DETAIL:

The firm submitted grievance with reference Technical Evaluation Report and submitted following grievance that the firm has attached copy of CNIC with the bid and has again attached with the grievance in favor of item no. 4 Disp Crescent Knife, item no.22 Disp Phaco Knife 2.75, item no.24 Disp Phaco Knife 3.2, item no.17 Micro Forceps 23 end, item no.16 Micro Forceps 23 ilm, item no.18 Microscissor 23. The firm also claims to attach copies of ISO certificate, market references and the documents related to technical staff that was already attached with the bid. The firm has requested to consider bid for further process to ensure healthy competition.

Decision:

Mr. Ali Akbar, Business Development Manager of firm pleaded the case before the grievance committee meeting. The committee observed that Technical Evaluation Committee has disqualified the bid due to failure in clause 6 of Part-A as ENIC copy of bid signatory was not attached. The firm
