

# CORRIGENDUM

## MAYO HOSPITAL LAHORE

The grievances committee held a meeting on 27.03.2024 in response to Letter No. PA/CEO/21316 dated 26.03.2024 where it has been directed by the procuring agency to review decision in light of relevant PTA documents required under clause j (Knock-down criteria Part-A):License of Walkie Talkie from PTA for Lahore.

**The decision under Item no. 1“GRIEVANCE SUBMITTED BY M/S BELFORT SECURITY SERVICES(TENDER CODE: OUTSOURCING OF SECURITY SERVICES AT MAYO HOSPITAL LAHORE)”in minutes of Grievances Meeting dated18.03.2024shall be read as follows:**

**Decision:**

Mr. Muhammad Shakeel, Deputy General Manager of M/S Belfort Security Services pleaded the case before the grievances committee. The committee observed that the Technical Evaluation Committee has disqualified the bid due to failure in Part-A. The committee observed that the firm has been disqualified in clause (a) of Part-A with the objection that the bidder is not an authorized person and his name is not mentioned on Form-29. The firm claimed that Col.® Syed Muhammad Abbas is the Managing Director of firm and showed Ministry of Interior U.O No. 437/2007-S-II dated 16<sup>th</sup> September 2022 about change in Directorship of M/S Bel Fort Security Services in favor of Col.® Syed Muhammad Abbas and others. It was also observed that the requirement of clause (a) stands for the firm as a bidder rather than signatory. The committee decided to declare firm responsive in clause (a) of part-A. The firm further claimed that it has PTA Wireless License No. W.6-39/2015/20 applicable to throughout Pakistan. The firm also showed receipt for renewal of PTA License. The firm's representative was then requested to show PTA License for Walkie Talkie for Lahore region which the firm failed to show during the meeting held on 27.03.2024 while stating that they have applied for the license. The committee decided to uphold the decision of Technical Evaluation Committee in clause (j) of Part-A. The firm




representative also requested to declare firm responsive in clause (k) of part-A as the TEC has mentioned that it is not signed by an authorized person. The committee observed that the affidavit has been signed by the Managing Director of the firm and decided to declare firm responsive in clause (k) of Part-A

**The firm remains Non-Responsive due to failure in clause (j) of part-A.**
