MINUTES OF MEETING OF ANNUAL TENDER F.Y 2024-25 OF MEDICINES / MEDICAL DEVICES ETC. HELD ON 20.04.2024 HELD IN THE CONFERENCE ROOM, SURGICAL TOWER AT 10:30AM

Meeting started at scheduled date and time in the conference room surgical tower Mayo Hospital Lahore. Multiple issues were discussed that were observed during the pre-bid meeting held on 20.04.2024, as per tender notice and the purpose of the meeting was widest possible competition in compliance of Punjab Procurement Rules 2014 (amended). - > In the technical evaluation criteria of medical gases A08 the following clauses are included in mandatory criteria, in addition to the previous criteria.
 - 1. The quoted VIE storage tank must be in compliance with EU / ASME standards.
 - 2. Valid license from Ministry of Energy (Petroleum Division), Department of Explosives, Govt. of Pakistan for both filling of compressed gases and liquid medical oxygen.
- > In the bidding document of medical gases A08 the payment schedule of the bidding document was not marked as Annexure F which is now marked as:
