Mayo Hospital Lahore invites e-bids from prospective bidders i.e from (manufacturer/importer/authorized agent/ distributor) who are registered with PPRA for E- Procurement on "E-Pak Acquisition and disposal system (E-PADS)" for procurement General /Stationary/Sanitation/MIR/Electric/bedding Clothing & Linen items, Orthopedic Raw Material for the financial year 2025-26 on free delivery to consignee end basis i.e Mayo Hospital, Lahore.

- 2. E-Bidding shall be conducted through Single Stage Two Envelope Bidding Procedure as per Rule-38 2(a) of PPR Rules, 2014 (ammended till date). Hard copies of bids are not required.
- 3. Interested eligible bidders can obtain the bidding documents along with detailed specifications and terms & conditions from portal of E-PADS (http://punjab.eprocure.gov.pk), PPRA website (www.ppra.punjab.gov.pk) and Mayo Hospital website (www.mayohospital.gop.pk).
- 4. Eligible bidders will submit their bids on E-PADS (<a href="http://punjab.eprocure.gov.pk">http://punjab.eprocure.gov.pk</a>) before the tender opening date. The e -bids will be opened in the presence of eligible bidders or their authorized representatives in the presence of Tender & Purchase committee in the Conference Room of Surgical Tower.
- 5. The bidders are required to submit the original 2 % Bid security in shape of CDR/Pay Order/Bank Draft on the date of tender opening as specified above, failing which the offer will be rejected.
- 6. The procuring agency shall not be responsible for any failure of part of firms to submit an e-bids or original 2% Bid security, any technical error or internet failure.
- 7. In case the date of opening is declared as a public holiday by the Government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of applications accordingly. The time and venue shall remain the same.
- 8. The bidders must submit the samples of quoted items in the relevant store to the designated pharmacist & store-keeper on the same day of tender opening.

Note: The procurement process including uploading on E-PADS shall be carried out as per Punjab Procurement Rules, 2014 (amended upto date)
