
PUBLIC AUCTION NOTICE

TERMS AND CONDITIONS

01. All citizens and firms of Pakistan are eligible to participate in Auction. Furthermore, the employees of Health and their relatives are not eligible to participate.
02. The Participant needs to deposit PKR Ten thousand (10,000/-) in cash as a Security and a copy of CNIC till 10:00 AM of the Auction Day.
03. The Participant who will offered highest value will be declared Successful bidder and has to deposit 25 % of the auction amount on the same day as cash/DD/P.O (No Checque will be accepted).
04. The successful bidder needs to deposit income tax 10% (in case of filer) and 20 % (in case of non-filer) on the same day within working hours, the successful bidders are bound to lift their acquired goods/items within five (05) days of the Auction Day from the relevant office(s)/ hospital(s).
05. In case of failure to deposit the full amount with taxes within five (05) days of auction, the deposited amount (25% of auction and security) will be forfeited and the 2nd highest offered value participant shall be considered as Successful Bidder.
06. In case of any damage occurred to Government building or property during the uplifting acquired goods/items, the successful Auctioneer must bear the cost.
07. During the Auction, the participant(s) must bring their Original CNIC and in case of firm must bring the authority letter as well.
08. The relevant instructions /rules issued by Govt. of Punjab are applicable.
09. The Advertisement and consolidated list of Auction items can also be sought from the website of Specialized Healthcare & Medical Education Department.
10. Only one person is allowed with the participant to participate in the Auction proceeding.
11. The timelines of Auction shall be strictly observed and no excuse shall be accepted from the participants in this regard.
