GRIEVANCE SUBMITTED BY M/S FOCUS SURGICALS (RE-TENDER FOR PROCUREMENT OF EYE DISPOSABLES R10 2025-26 MAYO HOSPITAL, LAHORE)

GRIEVANCE DETAIL:

Reference above said tender. We participated and quoted our DRAP enlisted Product/s against T.E No.30, which is already being successfully used by different Government, Semi Government and well reputed Private sector Hospitals and Eye Departments across Pakistan (Few Orders attached) and Internationally.

Above said report has been uploaded by the kind authority but Unfortunately we are declared 'Non-Responsive, on the basis of 'Less than 01 year experience' as per parameter No."X".

WE HAVE SUBMITTED OUR GRIEVANCE ON E.PADS on 13-10-2025.

It is humbly submitted that Our Product/s quoted "Phaco Knives" at Tender Serial No.30 falls in Class B for Medical Devices and was exempted from Enlistment by Drug Regulatory Authority of Pakistan till 30th December 2024,

We applied for Product's Enlistment months before its exemption period's deadline and got enlistment on Form-8A on 04/11/2024, well within the exemption period (Copy Attached). It is also worth mentioning that Sample Status of our quoted product also stands "APPROVED".

Decision:

Mr. Salman, Distributor of the firm presented the grievance before Grievance Redressal Committee. The committee observed that Technical Evaluation Committee has disqualified the e-bid due to failure in (x) of compulsory parameters. The firm claimed that its quoted item falls in class B of Medical Devices that was previously exempted and has more than 1 year experience and presented PO No. 1144574 dated 01.08.2024 issued by Mughal Eye Hospital Trust, POI No. POS-2505/009 dated 20.05.2024 issued by Ali Trust Free Eye Hospital Okara **The committee declared T.E. 30 quoted by firm responsive in section (x) of compulsory parameters.**

Decision:


Mr. Ali, representative of the firm presented the grievance before Grievance Redressal Committee. The firm claimed that it has DRAP registration of all quoted items. The committee observed that the firm had attached the same DRAP registration letters in the ebid (that were not considered) except MDIR-0007300 provided at the time of grievance meeting. The committee observed that the DRAP registration letters provided by the firm do not mention the quoted items. The firm claimed that the NIDEK Ophthalmic Surgical System contains all the quoted items of NIDEK Japan but failed to establish its claim. The committee observed that the firm attached the same DRAP Registration in the ebid that was not considered by the Technical Evaluation Committee. The committee decided to uphold the decision of Technical Evaluation Committee. However, the T.E. 1, 4, 11, 18, 21, 22, 25, 31, 32, 34, 36 & 62 provided by the firm were approved by Dr. Awais Senior Registrar Eye Department Mayo Hospital Lahore in sample evaluation. **The committee upheld the decision of Technical Evaluation Committee except sample evaluation responsive status of T.E. 1, 4, 11, 18, 21, 22, 25, 31, 32, 34, 36 & 62.**
