3. E-Bidding shall be conducted through Single Stage Two Envelope Bidding Procedure as per Rule-38 2(a) of PPRA, Rules, 2014 (amended till date). Hard copies of bids are not required.
4. The URL of the website of the PPRA is (<http://eproc.punjab.gov.pk/viewTender.aspx>) and response time shall be calculated exclusively from the date of publication of the advertisement on the website of the PPRA.
5. Interested eligible bidders can obtain the bidding documents along with detailed specification and terms & conditions from portal of E-PADS (<http://punjab.eprocure.gov.pk>), PPRA website (www.ppra.punjab.gov.pk) and Mayo Hospital website (www.mayohospital.gov.pk).
6. Eligible bidders will submit their bids on E-PADS (<http://punjab.eprocure.gov.pk>) before the tender opening date. The E-Bids will be opened in the presence of eligible bidder on their authorized representatives in the presence of Tender & Purchase Committee in the Conference Room of Surgical Tower.
7. The Bidders are required to submit the original 2% Bid Security i.e. (Rs.200,000/- of estimated cost mentioned in bidding document) in shape of CDR / Pay Order/ Bank Draft on the date of tender opening as specified above, failing which of offer will be rejected.
